The Director, Distance Education Council, Indira Gandhi National Open University, New Delhi vide letter dated January 31, 2002 has requested to submit a proposal for the Establishment of Centre of Distance Education at Mangalore University by February 2002. Accordingly a Project proposal has been proposed to be submitted to the Council. It is required that the proposal should include a resolution from the Executive Council/Syndicate of Mangalore University for establishing a Centre of Distance Education at the University.

As per the Karnataka State Universities Act-2000 under section-4 Powers of the University sub-section(1), "the University shall have the powers to provide for instruction (including instruction by correspondence), teaching and training in such branches of learning and course of study as it may think fit and make provisions for dissemination of knowledge and research". The proposed Centre would provide instructions through correspondence.






