Indian Constitution

Master's Degree in Political Science/ Law with minimum of 55% marks.

When no such candidate with above prescribed qualification is available, any other experienced faculty from Economics/ History/ Sociology having basic knowledge of the subject is eligible for teaching.

Human Rights

Master's degree in Political Science/ Law/ Sociology/ Social work with a minimum of 55% marks or any Post Graduate Degree with a minimum of 55% marks along with a Post Graduate Diploma (1 year) in Human Rights.

When no such candidate with above prescribed qualification is available, any other experienced faculty from Economics/ History/ Sociology having basic knowledge of the subject is eligible for teaching.

Gender Equity

Master's degree in Sociology/ Social Work/ Women's Studies with a minimum of 55% marks.

When no such candidate with above prescribed qualification is available, any other experienced faculty from Economics/ History/ Sociology/ Political Science/ English Literature having basic knowledge of the subject is eligible for teaching.

Environmental Studies

Master's degree in Environmental Science/ Botany/ Zoology/ Biosciences/ Microbiology/ Biotechnology/ Geography/ Marine Geology/ Geology with a minimum of 55% marks or any Post Graduate degree with minimum of 55% marks along with P.G. Diploma (1 year) in Environmental Studies.

When no such candidate with above prescribed qualification is available, any other experienced teacher from any faculty who has studied a paper on Environment at P.G. level is eligible for teaching.
