MEMORANDUM OF UNDERSTANDING

Between

MANGALORE UNIVERSITY Mangalagangothri - 574 199 and NITTE UNIVERSITY Deralakatte, Mangalore - 575 018

This Memorandum of Understanding entered into between Mangalore University, a University set up by the Government of Karnataka, represented herein by its Registrar, Shri. P. Prem Kumar I.F.S, hereinafter known as the First party and Nitte University, a Deemed University set up under section 3 of the UGC Act, 1956, represented herein by its Registrar Prof. N.S. Ramesh Murthy, hereinafter known as the Second Party witnesses as follows:

- Whereas Mangalore University is a well established University with several Post Graduate Departments of Study and Research and supporting the academic, research and extension activities in the areas of national and regional interests.
- And Whereas Nitte University, promoted by Nitte Education Trust, which
 has several well-known institutions including Medical, Dental, Engineering
 and other colleges and which the University has now in its ambit the
 Medical, Dental and other allied health science disciplines.
- And Whereas, Mangalore University and the several colleges of Nitte Education Trust have had fruitful academic and cultural exchanges over the years.
- 4. And Whereas, Mangalore University and Nitte University, of which the Medical and other colleges are now a part, wish to continue the common interests of the two Universities and further develop and enrich the academic and cultural exchanges between themselves.

NOW THIS MEMORANDUM OF UNDERSTANDING (MOU) WITNESSES AS FOLLOWS:

This MoU will promote activities in the following areas:

- Collaborative research, instructional, cultural and Extension programmes
 - (ii) Exchange of research information
 - (iii) Exchange of students
 - (iv) Exchange of faculty and staff

- Each of the above activities will be governed by specific norms to be established between the parties.
- C. The above activities will be carried out in such a manner so as not to digress from the established traditions and regulations of each party.
- D. The terms of this MoU may be modified and amended from time to time upon agreement between the parties.
- E. This MoU shall be valid initially for a period of Five years and be renewed automatically thereafter for a further period of Five years unless notified thereto by either party within three months of the expiry thereof.

These presents shall be signed by the respective Registrars on two sets of originals and signed copies shall be exchanged thereafter.
