MEMORANDUM OF UNDERSTANDING (MoU) BETWEEN MANGALORE UNIVERSITY AND YENEPOYA (DEEMED TO BE UNIVERSITY)

This memorandum of understanding, made on the 30th day of June 2022, between Mangalore University, Mangalagangotri, Karnataka (hereinafter referred to as Mangalore University) and Yenepoya (Deemed to be University), Deralakatta,

Mangalore, Karnataka (hereinafter referred to as Yenepoya (Deemed to be University) witnesseth as follows:

Preamble:

Mangalore University is a public institution established by the Government of Karnataka to promote higher education and research activities. Mangalore University offers several post-graduate courses in science, commerce, and arts and conducts research programmes in different areas of science, arts, commerce, and education. University Grants Commission (UGC) granted recognition to Yenepoya University Trust as a Deemed-to-be University status under section 3A of the UGC Act 1956 in 2008. It is involved in imparting quality higher education in health sciences and providing health care services and research programmes in medical sciences.

Mangalore University started a post-graduate course in Medical Physics (M. Sc. in Medical Physics) in 2018. The teaching programmes of this course require the infrastructural facilities and professional expertise available in the neighbouring medical institutions for conducting practical classes, teaching specialised course contents, training through hospital posting, and internship programme. Yenepoya (Deemed to be University) has established a state-of-the-art advanced comprehensive Yenepoya Cancer Care Center, Zulekha Yenepoya Institute of Oncology supported by TATA Trust and it is dedicated to teaching, research and providing quality health care for all sections of the society. This centre has advanced diagnosis facilities such as CT//PET/SPECT and treatment facilities such as Linear Accelerator/Brachytherapy systems true Beam etc. These facilities and the expertise available at Yenepoya (Deemed to be University) will be of immense benefit for the teaching, training and collaborative research programmes of Medical Physics students of Mangalore University.

On the other hand, Mangalore University has been extending the advanced facilities established in the Centre for Application of Radioisotopes and Radiation Technology (CARRT) and the Centre for Advanced Research in Environmental Radioactivity (CARER) to the research programmes of faculty/researchers of the Yenepoya (Deemed to be University) and these collaborative research programmes have increased over the years and resulted in research publications in reputed international journals.

Mangalore University and Yenepoya (Deemed to be University) wish to continue cooperating in teaching, training, and research programmes based on the mutually beneficial relationship built on academic and scientific cooperation. Hence, Mangalore University and Yenepoya (Deemed to be University) are establishing this MoU.

The Memorandum of Understanding (MoU) establishes the following

I. Scope of MoU:

To establish a mutually beneficial relationship built on academic and scientific cooperation between Mangalore University and Yenepoya (Deemed to be University).

II. Period of MoU and its extension:

This MoU becomes effective from the day the authorised representatives of both the institutions affix their signatures below and will continue for five years, after which it shall be reviewed, and it may be extended by a mutual written agreement of both the institutions. This MoU may be revised through the mutual agreement of both institutions. Either party may terminate this MoU upon giving six months' written notice with reasons for termination and signed by the Head of the Institution of the notifying party. In case of termination, the ongoing internship/training programme of the students shall not be affected and they shall be allowed to continue and complete the programme.

III. Field of cooperation:

Cooperation between the two institutions may be established within any field related to science and technology of mutual interest and, in particular:

- Mutual cooperation and participation in teaching and training programmes of both institutions.
- ii. Extending facilities available with both institutions for each other's students' training, conducting practical classes and deputation of students as observers.
- iii. Providing training and conducting practical classes for the M Sc Medical Physics students of Mangalore University using the advanced radiotherapy instruments available at Yenepoya (Deemed to be University).
- iv. Providing internship placement for at least ONE M. Sc. Medical Physics student per year of Mangalore University at Yenepoya (Deemed to be University).
- v. Training of doctoral students and extension of each other's facilities for research.
- vi. Development of joint research activities.
- vii. Exchange of information, including the results of teaching and research collaboration.
- viii. Extension to other areas will be considered and made through appropriate amendments to the present MoU.

IV. Exchange of scientists/experts/faculty:

- i. Mangalore University and Yenepoya (Deemed to be University) will participate in each other's teaching and training programmes.
- Remuneration for taking theory and practical classes for students will be paid to experts/faculty by respective institutions as per their institutional norms.
- iii. Mangalore University will extend its research facilities to faculty, scientists and research/Post-Graduate students of Yenepoya (Deemed to be University) for scientific research as per the institutional norms.

- iv. Reciprocally, Yenepoya (Deemed to be University) will extend laboratory facilities to faculty, scientists and research students from Mangalore University for scientific research as per the institutional norms.
- v. Both the institutions agree to seek financial support for collaborative research programmes from appropriate funding agencies.

V. Intellectual property rights:

Information on research results and scientific materials (reports, articles, books) will be exchanged freely keeping in mind the mutually agreed provision of Intellectual Property Rights. All intellectual property solely conceived and/or developed by Mangalore University during the course of this agreement shall be owned by Mangalore University. All intellectual property solely conceived and/or developed by Yenepoya (Deemed to be University) during the course of this agreement shall be owned by Yenepoya (Deemed to be University). Intellectual property jointly conceived and/or developed by Mangalore University and Yenepoya (Deemed to be University) will be jointly owned by Mangalore University and Yenepoya (Deemed to be University). Each party may use such property for research and scholarly purposes with prior information to the other party and with their consent. Mangalore University and Yenepoya (Deemed to be University) agree to collaborate towards the protection, if appropriate, and application of such intellectual property for commercial or other purposes on mutually acceptable terms to be negotiated in good faith between the parties.

VI. Confidentiality:

During the tenure of the MoU, both Mangalore University and Yenepoya (Deemed to be University)will maintain strict confidentiality and prevent disclosure of all the information and data exchanged under the scope of this MoU for any purpose other than in accordance with this MoU. Both Mangalore University and Yenepoya (Deemed to be University)shall bind their respective personnel who come into possession or knowledge of any confidential information

not to disclose the same to third parties without the written approval of the disclosing party or use such confidential information for any use other than intended under this agreement. Further both Mangalore University and Yenepoya (Deemed to be University)shall put in place adequate and reasonable measures to keep and store confidential information secure so as to prevent any unauthorised use.

VII. Research Publications:

Research publications arising out of collaborative research work shall be in the names of the investigators from both parties, with prior mutual consent of both parties. It will be suitably acknowledged that the work has been carried out jointly

under the aegis of corresponding funding agencies.

VIII. MoU and its amendments:

This MoU shall be the sole repository of terms and conditions agreed between the parties, and no amendments thereof shall take effect or be binding on Mangalore University and Yenepoya (Deemed to be University)unless such amendment is mutually agreed by both the parties and is recorded in writing and signed by the

authorised representatives of both the parties.

IX. Resolution of disputes:

Any dispute or difference arising between the parties shall be resolved bilaterally by the Vice-Chancellors of Mangalore University and Yenepoya (Deemed to be University), and the decision so arrived shall be final and binding on both parties of this MoU.

This MoU is made in three originals (Mangalore University keeps two originals,

and Yenepoya (Deemed to be University) will keep one original).
